# GENERAL CONDITIONS OF RENT

## Article 1: Reservation

Any reservations implies the acceptance of the internal regulation of the Municipal Campsite of Port Sable and the conditions expressed below.

Any reservation is non transferable and cannot be given up or sublet.

The reservation concerns only a minimum stay of 7 nights. The reservation is effective only after confirmation and collection of the deposit by the administrator.

- In the reservation: payment of the deposit by the administrator.
- Pay of the stay the day before the departure

\*the deposit: the cancellation of the reservation entails the loss of the amount of the deposit but does not oblige you the execution of the contract.

## Article 2 : Booking Cancellation

- Must in writing
- No refund will be granted for a delayed arrival, an early departure or absences in the course of stay.
- In case of cancellation of the stay, the deposit is lost, except for illness (provide proof).

## Article 3: Arrival and departure time

The day of arrival and of departure is at choice.

Arrival are from 15pm and departures are before noon.

An overnight stay is from 3pm till noon.

An extra time stay is possible according to our availabilities. In case of delayed arrival, thanks for warning the reception as soon as possible. The reservation is kept 24 hours after the planned date of arrival. Crossed the deadline, the reservation is lost.

## Article 4: The Pitch

The attribution of the pitch is decided by the requirement of the booking schedule by the campsite's administrator.

## Article 5: Pets

Pets are allowed in the campsite (for an amount of 1.70 € per day and per animal). They must be inoculated (updated rabies vaccine) have a chip or tattooed. The vaccination record will be asked you upon your arrival. We remind you that in application of the law 99-5 of January 6<sup>th</sup>, 1999, first category's dogs are forbidden, within the campsite, and second category's dogs are allowed, muzzled and kept on a lead by a major person, with a licence to possess.
